Access is suitable for future logging, and the property supports strong populations of deer, turkey, and feral hogs. Two well-defined Streamside Management Zones (SMZs) contain mature white oak and red oak, providing consistent acorn production and enhancing overall wildlife habitat.

**ACCESS:** The tract is reached via a long-standing access route from Tarver Road across Ozark Mountain Timber Company property. Although this access is not deeded, the adjoining landowner has consistently been cooperative, including allowing passage and logging access in prior operations. Prospective buyers should verify access to their own satisfaction.

**LEGAL DESCRIPTION:** South 1/2 of Northeast 1/4 of Section 27, Township 11 North, Range 4 East, LaSalle Parish, Louisiana.

**TIMBER:** The tract supports a genetically improved loblolly pine plantation approximately 22 years of age. It was thinned in 2023 and is projected to be ready for an additional thinning in 3–5 years. This stand offers strong growth potential and represents an excellent long-term timber investment.

**MINERALS:** This property is offered for sale with the seller reserving all (100%) of the mineral rights (oil, gas, and associated hydrocarbons).
